“Considerations for Professionals Working with Substance Use Disorder – Helping Families and Children”
Kyle Pillans

Addiction is a disease that impacts everyone in the family. Family members need as much help and support as the individual suffering from substance use disorder. Often children are not included in the process. Children are usually the first hurt and the last helped in the midst of this disease. This presentation will teach one how to address the disease of addiction with children age 6 and up. It will provide a safe and simple narrative for open discussion and understanding within the entire family system.

Kyle Pillans has been a Children’s Counselor with the Children’s Program since October 2006. She is educated to work with individuals who experience physical, mental and emotional disabilities so they can function productively in their daily lives. She has worked specifically in the addiction field since 2004. She worked in adult inpatient treatment program before coming to the Betty Ford Center in Irving, Texas. Kyle works with local schools and community partners to provide the Children’s Program and coordinates the volunteer program. Kyle trains professionals, educates the community and works directly with children and families.

- 1. Identify common concerns in working with children impacted by substance use disorder.
2. Learn specific terms to discuss substance use disorder age appropriately with children age 6-13.
3. Identify major messages children impacted by substance use disorder need to know.
